

REGIONAL TRAINING FOR VICTIM ADVOCATES

Regional Training has been confirmed at the following locations.

The first regional training will be held in on Monday, April 12th, 9:00am – 3:00pm, at the Hilton Irvine Orange County Airport.

The second regional training will be held on Tuesday, April 13th, 9:00am – 3:00pm, at the Executive Inn, Oakland.

The third regional training will be held on Wednesday, April 28th, 9:00am – 3:00pm, at the Holiday Inn, Sacramento.

The training topic and instructor will be the same at all regional trainings. The CVSTI Training Committee has selected the topic to be presented as: “Working with Immigrant Populations” (who are domestic violence and/or sexual assault survivors).

The presentation will be 5-hour class specifically designed for victim advocates which will provide an overview of immigration law and procedure, types of immigration relief, eligibility and procedure, how victim advocates can help identify and assist people who might be eligible for relief; how to build bridges to the immigrant community to encourage crime reporting and better serve victims of crime.

The presenter is Susan Bowyer, Managing Attorney for the International Institute of the Bay Area. The Institute helps families that have been separated by the migration experience to reunify through family visa petitions, helps legal residents gain citizenship, assists undocumented battered immigrant women and children gain legal status, helps with Temporary Protected Status (TPS), with Nicaraguan and Central American Relief Act (NACARA) applications, and provides advice and counsel on immigration legal matters.

Lunch will be provided to all attendees. A \$25 registration fee is covered by automatic scholarships for attendees from all CCVAA membership agencies.

You may submit a scholarship application for reimbursement for other applicable costs (hotel, travel, parking, etc.) A scholarship application form is available on the CVSTI website and must be submitted by April 7nd for the Orange County/Oakland Trainings or April 16th for the Sacramento Trainings.

All persons who wish to attend a Regional Training must complete the registration form below by April 8th for the Orange County/Oakland Trainings or April 22nd for the Sacramento Training.
